## **Iowa County Private Land Youth / Mentor Hunt Application**

Sheboygan County Conservation Association is privileged to have been given the opportunity to take 3 youth hunters on a back county style deer hunt. This hunt will take place in Iowa County, Wisconsin (2.5 hour drive from Sheboygan). Hunters and Mentors will find a back country style camping experience. SCCA will provide (through our Youth Program, Donors, Sponsors and Mentors) shelter and sleeping tents, a mess hall tent where volunteers will cook and supply meals and hunting stands/blinds. The back country style camp is located right on the hunting property, so once you arrive, you won't need to travel at all.

This property is in the heart of world class whitetail deer hunting. Per the property owner's request, this hunt will be for Antlerless Deer ONLY, although the chance to witness world class Bucks in the wild are expected.

This trip is offered to Youth Hunters, ages 12-15 (as of October 8<sup>th</sup>, 2023). Hunters will need to be accompanied by a parent or guardian. A Mentor Hunter/Volunteer will be supplied by the SCCA to assist in all aspects of the hunt. On this hunt, we look forward to not only the harvest of a deer, but also the field dressing, transportation and camp atmosphere for the youth hunters and all involved. This opportunity is designed to create a traditional Wisconsin Deer Hunting experience for our next generation. Hunters will need the required harvest gun deer license issued by the DNR.

We will be selecting 3 Hunters to participate in this trip. Arrival at the property would be Mid-day October 6<sup>th</sup>, 2023 and Hunting would take place on the 7<sup>th</sup> and 8<sup>th</sup>. Deadline for applications will be August 14<sup>th</sup>, 2023 with selection made on August 16<sup>th</sup> at the Monthly SCCA Meeting. Those hunters that are selected, will be asked to attend a short get together prior to the hunt at a local conservation club to sight in firearms and get to know one another. While Hunters Safety is not required for the Mentor Hunt, we strongly recommend having it completed before this hunt. We are also more than happy to help set that up for you if it is needed.
