## **Iowa County Private Land Youth / Mentor Deer Hunt**

## **Application**

Sheboygan County Conservation Association is privileged to have been given the opportunity to take 2 youth hunters on a back county style deer Hunt. This hunt will take place in Iowa County Wisconsin October 5<sup>th</sup> & 6th 2024 with arrival @ the property Mid-Morning October 5<sup>th</sup> a ( 2 ½ hour drive from Sheboygan). The hunt will begin the evening hunt on October 5<sup>th</sup>, morning hunt on October 6<sup>th</sup> and the evening hunt that same day. Departure will be Monday morning October 7<sup>th</sup> with the reason being we would like to have the hunters get 2 evening hunt in. Hunters and Mentors will find a back country style camping experience. SCCA will provide (through our Youth Program, Donors, Sponsors and mentors) shelter and sleeping tents, a mess hall tent where volunteers will cook and supply meals & an area to socialize. Hunting stands and blinds will be supplied by the SCCA. The back country style camp is located right on the hunting property, so once you arrive you won't need to travel at all.

This trip is offered to Youth Hunters ages 12-15 (as of October 6th 2024). Hunters will need to be accompanied by a parent or guardian. A Mentor Hunter/Volunteer will be supplied by the SCCA to assist in all aspects of the hunt. On this hunt, we look forward to not only harvest a deer, but also the field dressing and camp atmosphere for the hunters and all involved. This opportunity is designed to create traditional Wisconsin Deer Hunting experience for our next generation.

Hunters will need the required deer harvest license from the DNR which the SCCA will help you with. Deadline for applications will be August 18th 2024 with selection made on August 21st at a SCCA monthly meeting. Hunters that are selected, will be asked to attend a short get together prior to the hunt @ a local conservation club to sight in firearms and get to know each other. While Hunters safety is not required for a mentor hunt, we strongly recommend having it completed before this hunt and the SCCA would be happy to help set that up for you if needed.
