

Dear Sir:

We are writing to you in regard to the disturbing acts that have come to light involving individuals who participated in the assault, abuse, killing/poaching and total disregard of wildlife and resources

The Sheboygan County Conservation Association is a group that consists of 26 local conservation clubs with over 2,200 individual members. As an Association we pride ourselves on ethical stewardship of all aspects of land, water and wildlife. These acts committed by these few individuals are not only a slap in the face to all of society, they are disgusting acts the undermine the efforts of true sportsman and women who dedicate a huge part of their lives to preserving the environment and wildlife for future generations and all of society to enjoy. Not only does the wildlife in Wisconsin offer many sources of pleasure and recreation to our citizens, both in-state and out-of-state, things like hunting is a huge contributor to our economy.

The acts that were committed were in our minds go beyond criminal, they are disgusting and deplorable by society's standards. It is our ask and with our full support that we request that these individuals be prosecuted to the fullest extent by law without acceptance of any type of deal to minimize the consequences these individuals deserve.

2. WATER/HABITAT CONSERVATIONIST(S) OF THE YEAR

For outstanding overall conservation effort in the water/habitat field and achievement by an individual, organization, club or group, for significant contribution to the cause of conservation, or meaningful progress or achievement toward a solution of a major conservation program or problem. This award is for the year 2024.

3. YOUTH CONSERVATIONIST OF THE YEAR

What has this person done for conservation locally, in the county or for the State of Wisconsin? How long have they been active in their conservation efforts? *Please include a detailed list of his/her accomplishments in 500 words or less.*

4. CLUB OF THE YEAR

Criteria: **For outstanding activity by a club in the year 2024.** You may nominate your club or any other club in the Sheboygan County Conservation Association. Conservation efforts and accomplishments, community service projects and involvement, outdoor education projects, hunter safety and gun safety training, habitat enhancement, invasive species projects, recreational club activities, club projects, club fundraisers, utilization of funds, and club donations will count towards this award. *Use the nomination title page & one additional page to detail specifics in 500 words or less.*

5. CONSERVATION EDUCATOR OF THE YEAR

For an outstanding effort in education by an individual in the 2024 year in the field of conservation outside of Hunters Education.
